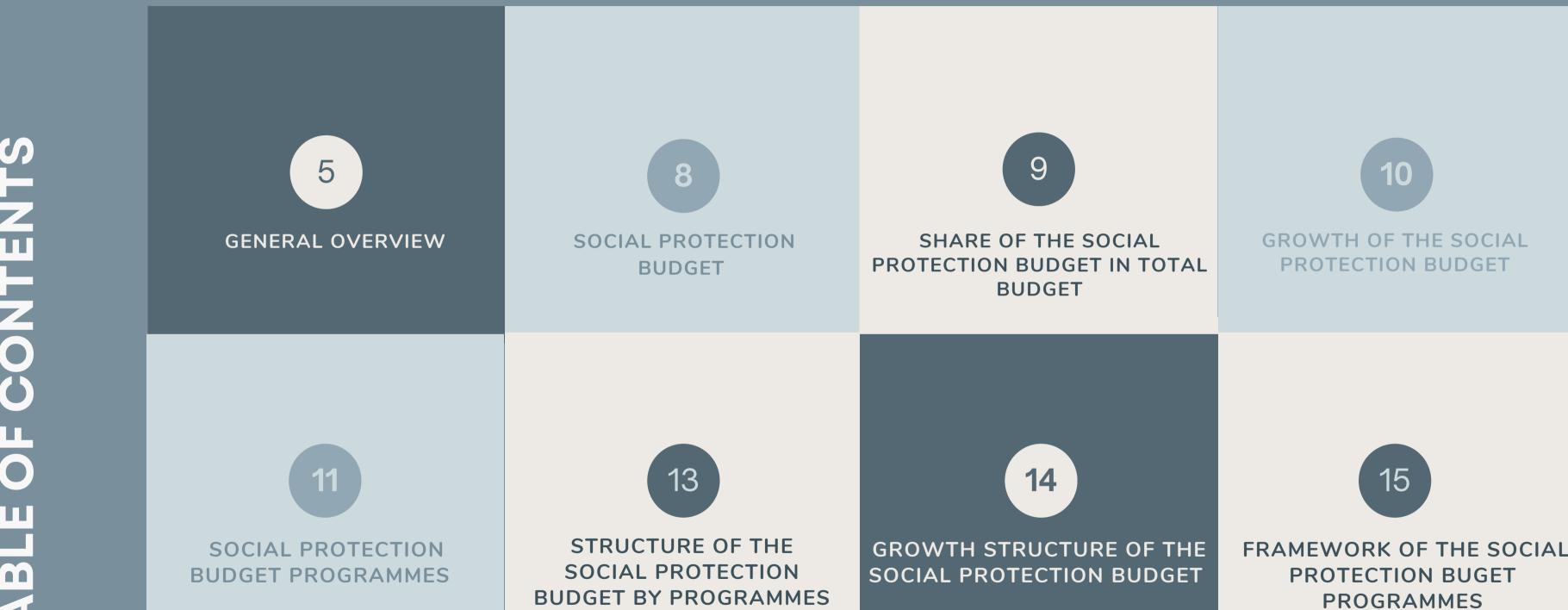

The 2024 budget data is programmatic, while data for 2023 and earlier years is based on actual figures. General Overview

- The 2024 Annual Budget Law of the Republic of Armenia involves - AMD 2,723.6 bln revenues, AMD 3,206.5 bln expenditures and a deficit equaling to AMD 482.9 bln, or 25.9%, 30.5% and 4.6% of the GDP respectively.
- Expenditures on the social protection in the Annual Budget are presented under the social protection programmes, which are coordinated by the Ministry of Labor and Social Affairs (MLSA).
- Social protection continues to be one of the priority areas of the state policy, with the main objective to eliminate extreme poverty in the country, significantly reduction of the poverty level, improving demographic situation and providing social guarantees to the certain population groups in the Republic of Armenia.
- Allocations to the Social Protection Pogrammes in 2024 will amount to AMD 795.3 billion, which exceeds the level of the previous year by more than AMD 89.7 billion or 12.7%.
- Allocations to the Social Pogrammes in 2024 will amount to 7.6 % of GDP, against the average level of 7.8% in 2019-2023, and 24.8 % in relation to the total expenditures of the Annual Budget, compared to the average of 27.9 % for the last 5 years.

- The growth of financing of the social protection sector is relatively stable. The average annual increase in the funding of social protection programmes for the period 2020-2024 is 12.1 %, and is yielding to the average annual increase in the total expenditures of the Annual Budget by 2.6 percentage points during the same period.
- The state policy of social protection in 2024 will be implemented through 17 budget programmes.
- Social security programmes are the leaders among the social protection programmes in terms of allocation. These are: Pension Security and Social Security programmes. The financing of these programmes constitutes respectively 62.1% and 14.2% of the budget of MLSA programmes.
- 59.8% of the pension insurance is allocated to labor pensions. No increase in pensions is planned in 2024. The average labor pension will total to AMD 50,414 in 2024, compared to the actual level of AMD 47,593 of the last year.
- Although no increase in pensions is expected in 2024, yet the Government is targeting an increase in labor pensions during the MTEF (Medium-Term Expenditure Frameworks) period, having the aim to ensure an average monthly pension equal to the value of the minimum consumer basket in 2026.

- Within the scope of the social security programme 105,994 citizens receive benefits in case of old age, disability, or loss of a breadwinner.
- The next in terms of financing volumes are budget programmes Improving demographic situation and Supporting insecure social groups, with shares of 8.7% and 4.0 %, respectively.
- There is a sharp increase in the number of beneficiaries of 1) Benefits for children under 2 years old, 2) One-off child benefit, and 3) AMD 50,000 of benefits for families with 3 and/or more children in the family.
- More than AMD 31.9 billion will be allocated to the Support programme for insecure social groups, which exceed the actual expenditures in the previous year by 19.3%. The budget of this programme is 4 % of the social protection budget.
- In 2024, the average amount of Living standards enhancement benefits will total to AMD 37,000. 66,849 families including 3,183 families forcibly displaced from Nagorno-Karabakh will receive the benefits.
- The Social Protection Budget increase in 2024 is mainly determined by increased allocations to the Pension Security and Social Security programmes. The financing volumes of these programmes will increase by AMD 53.2 and AMD 21.7 billion respectively.

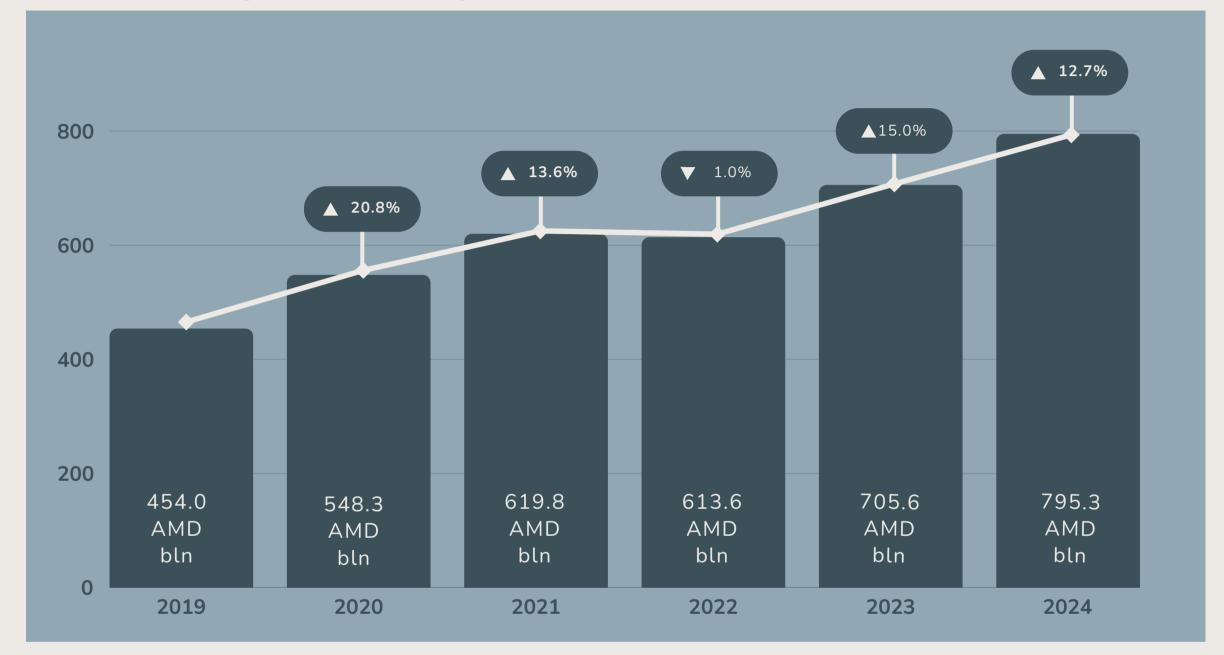
- Pension Security and Social Security programmes together make up for the 83.5 % of the increase in the volume of financing of the sector. Note that more than 25 % of this increase is due to the inclusion in the number of pensioners and beneficiaries who were forcibly displaced from Nagorno-Karabakh, into the RA systems. The number of NK beneficiaries of the Pension Security programme is 21,696 people.
- The next are increases in resources allocated to the improvement of Demographic Situation and Support to Insecure Social Groups, which together provide 22.8 % of the increase. The growth of the programme for the improvement of Demographic Situation is the evidence of the increasing influence of this programme on the large families.
- In 2024, the number of families receiving a one-off child benefit will increase. In particular, the number of beneficiaries for the third and subsequent children will grow by 9.9 %, amounting to 14,037 families.
- Number of beneficiaries receiving maternity benefits will increase by 12 % and amount to 40,118 people, including 2,118 people displaced from Nagorno-Karabakh.
- Financial resources allocated to the provision of child care and support services will increase significantly.
- Works on building conditions improvement of SNCOs providing round-the-clock care for elderly people and children will be launched.

- A new "Personal Assistant Service" will be launched for people with disabilities.
- Providing social support to families forcibly displaced from Nagorno-Karabakh to live in temporary housing and to help them pay for utility services will continue for a period 3 months in the amount of AMD 50,000 per month.
- The support to ensure affordable housing for displaced families from different regions of Nagorno-Karabakh will also be continued. AMD 2 billion will be allocated to support 4,032 families in acquiring real estate or construction of an individual residential house.
- 540 families will receive state support for affordable housing in border settlements.
- Providing vocational training and ensuring employment services for unemployed persons, who took part in the military operations as a result of the war unleashed by Azerbaijan in 2016 and 2020, will continue.

- AMD 1.5 bln will be allocated for Compensation of deposits in 2024. Within the framework of this programme, around 8,000 beneficiaries who are deposit holders in "VTB-Armenia" CJSC and the Republican Bank of the Savings Bank of the USSR of the Armenian SSR as of 10 June, 1993 will receive compensation. Deposit holders born up to and including 30 June, 1941 have the right to compensation.
- Within the framework of the Provision of Social Package programme, AMD 10.6 bln will be allocated to provide social packages to 147,493 public sector employees.
- The Second credit programme under the Social Protection Administration Project (SPAP) funded by the World Bank is coming to an end. Certain works on the repair of the premises and furnishing of the Unified Social Service will be continued and completed within the framework of the project in 2024.
- AMD 8.6 bln will be allocated to the development social protection policy, programme coordination and monitoring, which is increased by of 3.1 % compared to the previous year. AMD 149.7 mln will be allocated to the implementation of sectoral research and personnel training.

Social Protection Budget and its annual growth (%) in 2019-2024

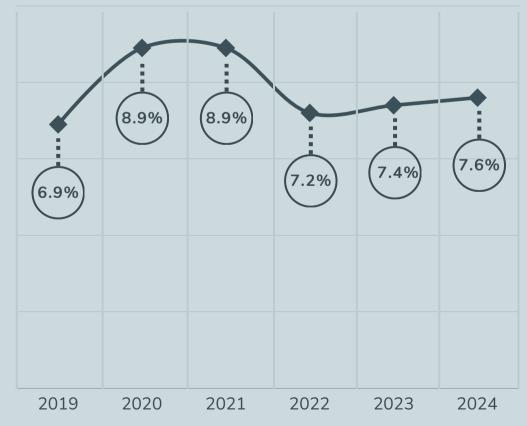

- Total allocations to Social Protection Sector in 2024 Annual Budget will equal to AMD 795.3 bln. Compared to the previous year, these allocations in 2024 increased by AMD 89.7 bln or 12.7%.
- Social Protection Sector financing is increasing. In 2020-2024, the average annual growth in funding volumes will total to 12.1%. As a result, the volume of financing in 2019 will be exceeded for more than 1.8 times, or by AMD 341.4 bln.

- The social protection budget for 2024 will amount to 7.6 % of the GDP, which is 0.2 percentage points higher than the level of the previous year.
- During the 5 years prior to 2024, the average level of the Social Protection Expenditure/GDP ratio was 7.8 %

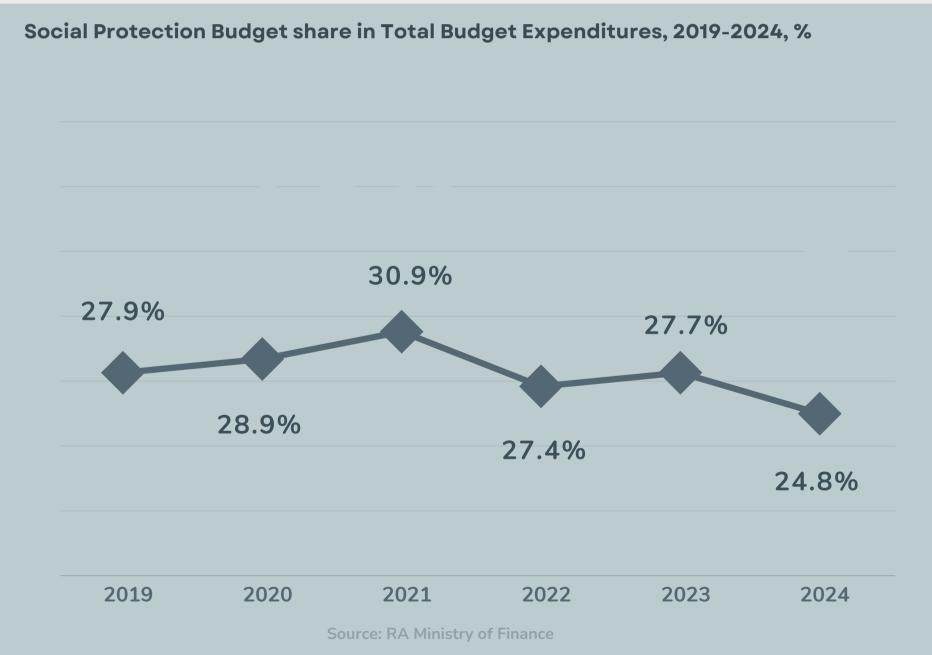
Share of the Social Protection Programme Budget in Total Budget Expenditures and GDP, 2019-2024

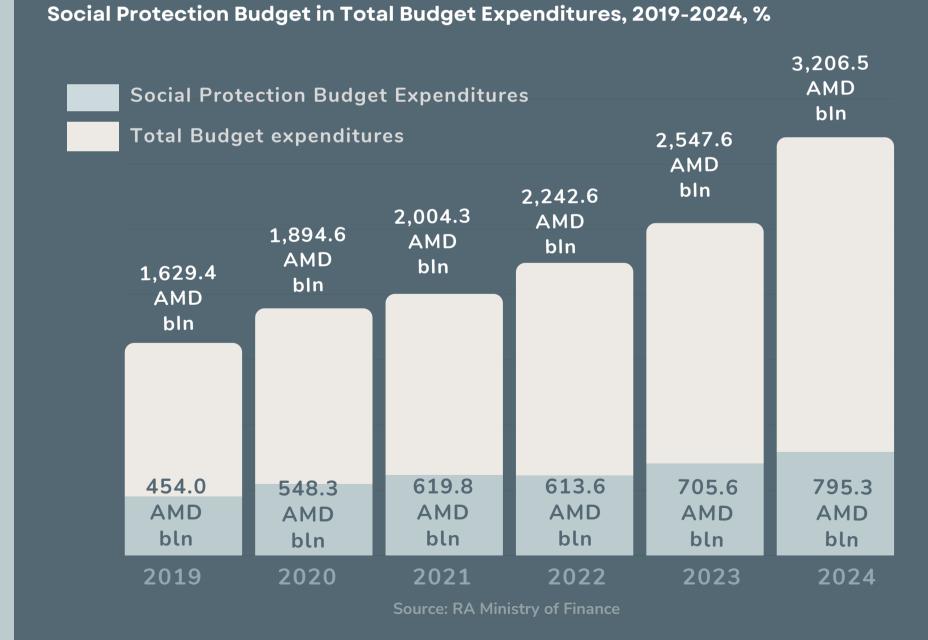

SHARE OF THE SOCIAL PROTECTION BUDGET IN TOTAL BUDGET

- Social Protection Budget Expenditures in 2024 will amount to 24.8%, which is lower by 2.9 percentage points compared to the previous year.
- The share of Social Protection expenditures in Total budget expenditures is lower in 2024 compared to all previous five years. The average level of the social protection budget expenditure ratio was 27.9 %.
- The average annual growth rate in social protection expenditures is lower than the corresponding indicator in the state budget expenditures. The average annual growth of the total budget expenditures in 2020-2024 was 14.7 %, with a 12.1 percent level of the social protection budget.

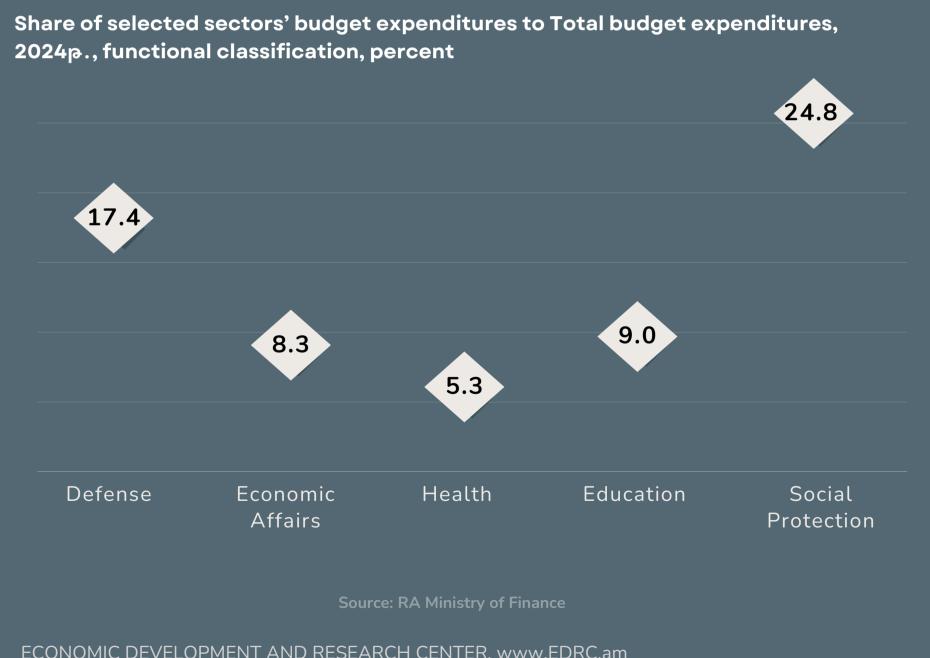


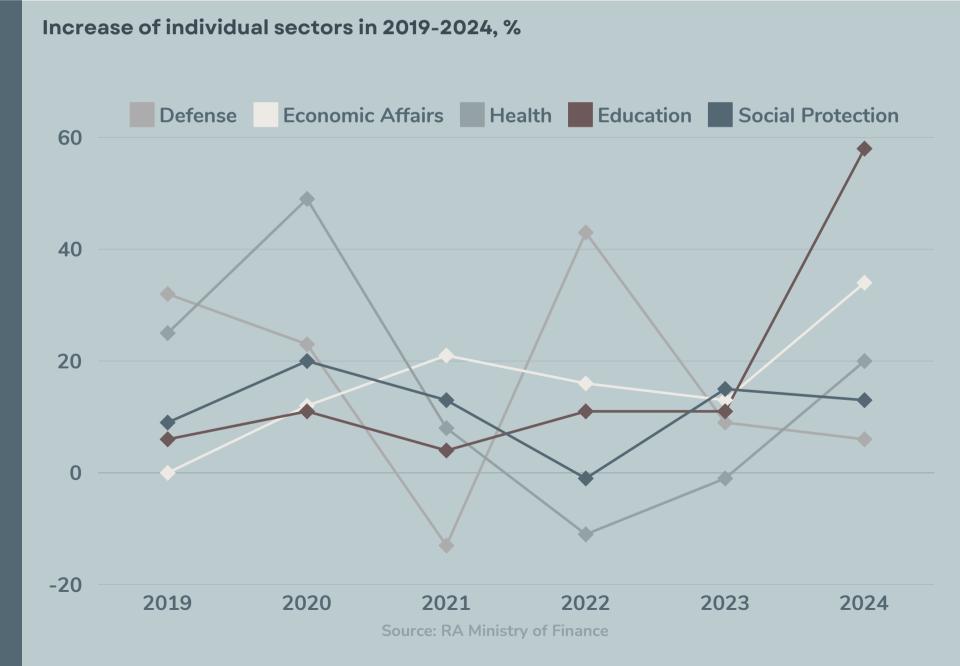


GROWTH OF THE SOCIAL PROTECTION BUDGET

- Social Protection is the largest functional section of budget expenditures.
- All other budgetary chapters yield to social protection. In particular, the ratio of defense sector expenditures/state budget expenditures is 17.4%, yielding by 7.4 percentage points, the share of education sector is 9%, yielding by 15,8 percentage points, the economic affairs yield by 16,5 percentage points, etc.

- The growth in funding for the social protection sector is relatively stable.
- As we can see from the chart below, the growth of social protection budget in 2024 is the fourth largest compared to the growth of the selected sectors. Note that in 2023 there is a completely different situation, when social protection showed the largest growth compared to other sectors

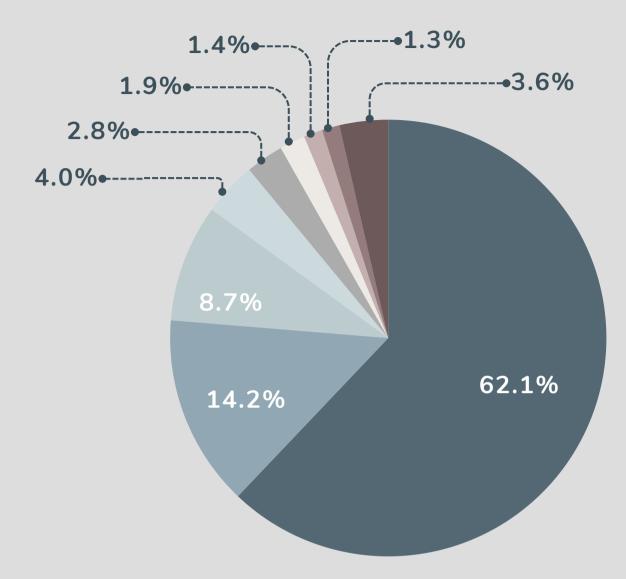

STRUCTURE OF THE SOCIAL PROTECTION **BUDGET BY PROGRAMMES**

- The largest budget programme in the Social Protection sector is the Pension Security Programme to which 62.1% of budget is allocated.
- Budget programmes Social Security, Improving Demographic Situation and Support to Disadvantaged Social Groups follow with shares of 14.2%, 8.7% and 4% respectively.
- In total, the four largest programmes ensure 89 % of the Social Protection budget.

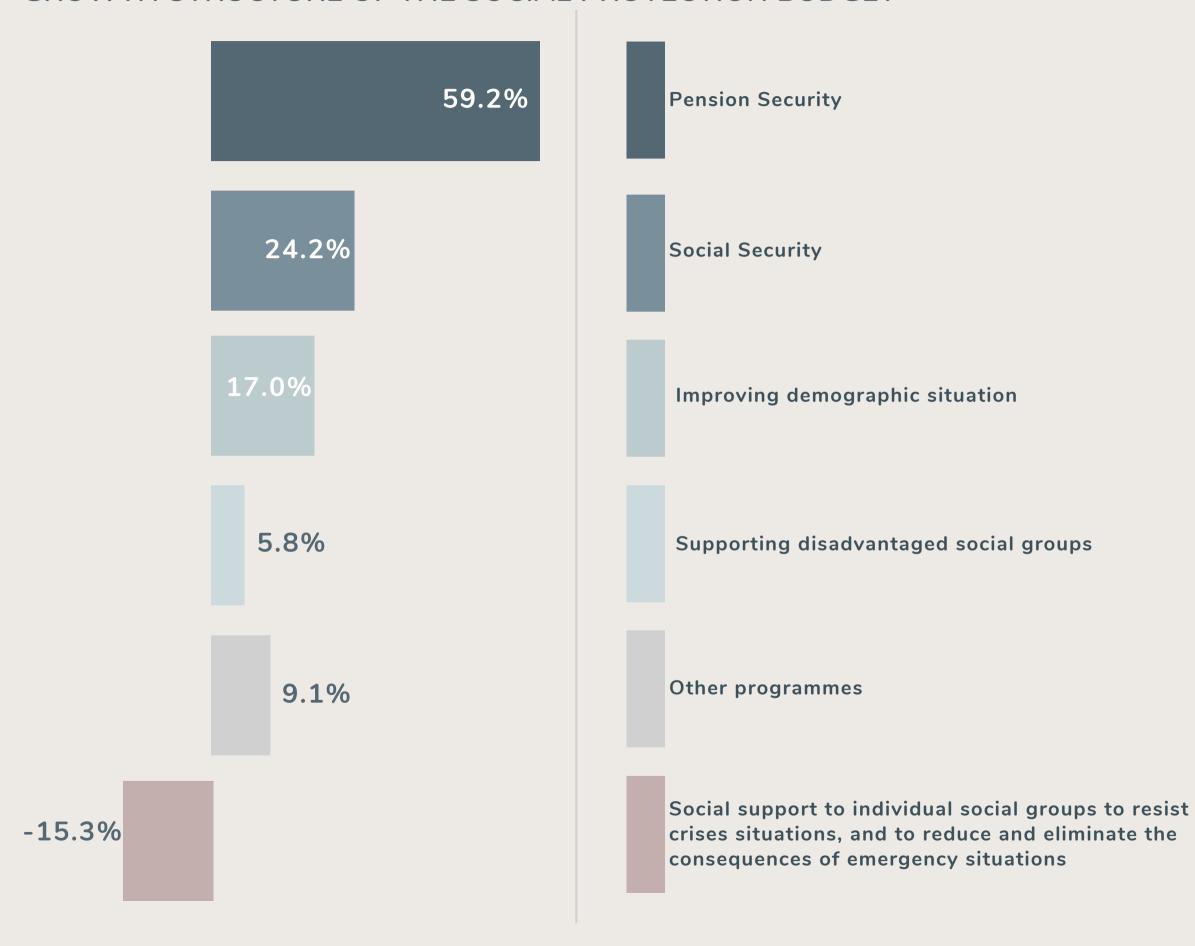

- Increase in the budget for Social Protection programmes in 2024 will amount to AMD 89.7bln.
- Increase in the Social Protection budget is mainly due to the increased funding for four budget programmes.
- More than 83.5 % of the increase in the Social Protection budget is allocated to Pension and Social Security programmes.
- Increases in allocations to improving the demographic situation and supporting disadvantaged represent 22.8% of total increase in allocations

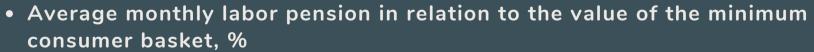

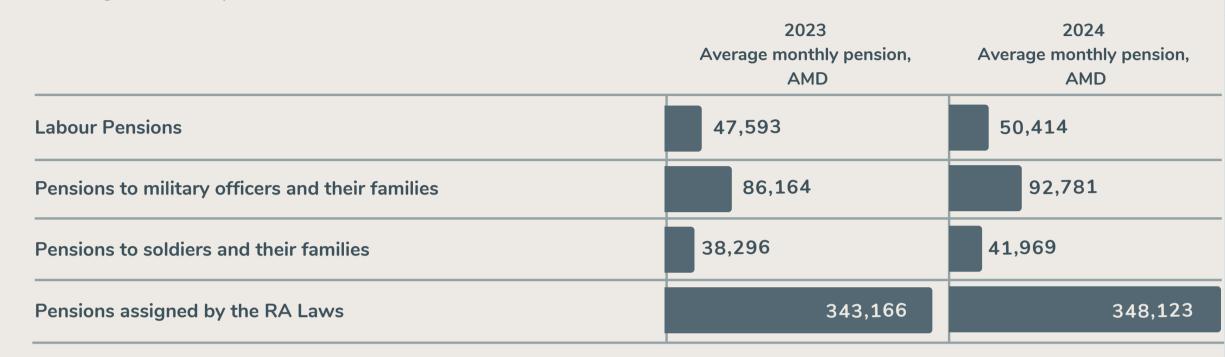


• Minimum monthly labor pension in relation to the value of the minimum consumer basket, %

- More than 69 % of programme resources, or AMD 340.9 bln, will be allocated for paying the pension.
- Number of beneficiaries of the pension system is 527,699, of which 4.1 % are our compatriots forcibly displaced from Nagorno-Karabakh.
- Pensioners receiving labour pension make 92.6%, or 488,402 people, including 20,439 forcibly displaced from Nagorno-Karabakh.
- Average pension in 2024 is projected to equal to AMD 50,414, which is higher by AMD 2,821 compared to the previous year.
- In 2024, AMD 152.3 bln will be allocated for payments to the participants of Cumulative Pension System.

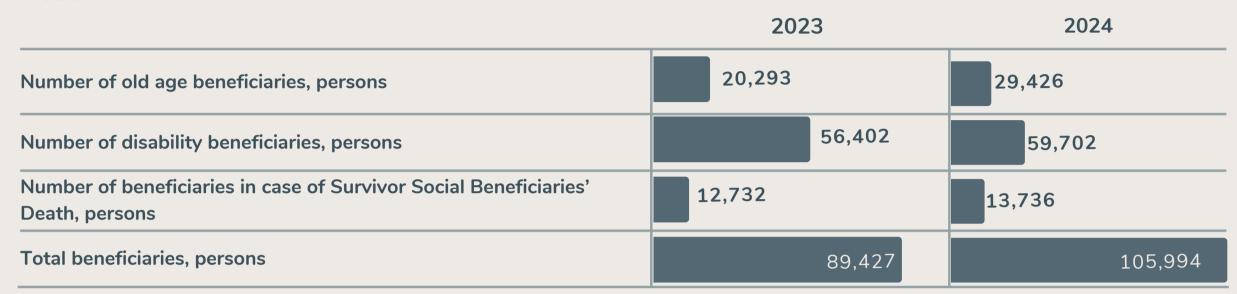

- Within the scope of the social security programme 105,994 citizens, including 3,130 beneficiaries forcibly displaced from Nagorno-Karabakh, receive benefits for old age, disability, or Survivor Social Beneficiaries' Death.
- The number of beneficiaries increased by 16,567 people or 18.5 % compared to the previous year.
- 56.3 % of beneficiaries are recipients of disability benefit. Old age beneficiaries are only 27.8 % of total number of beneficiaries.
- It is projected that the number of beneficiaries receiving refund to pensioners from the non-cash payments in 2024 will amount to 230,000, which is about 40 % more than the level of 2023. The average refund per beneficiary is AMD 3,700.

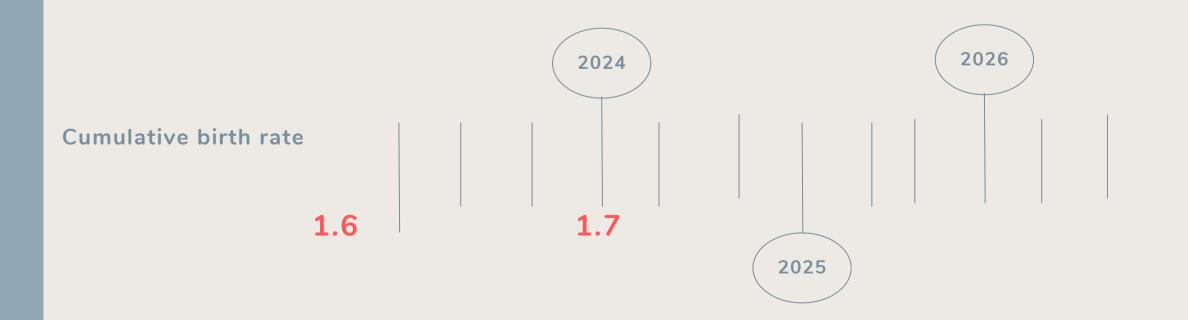

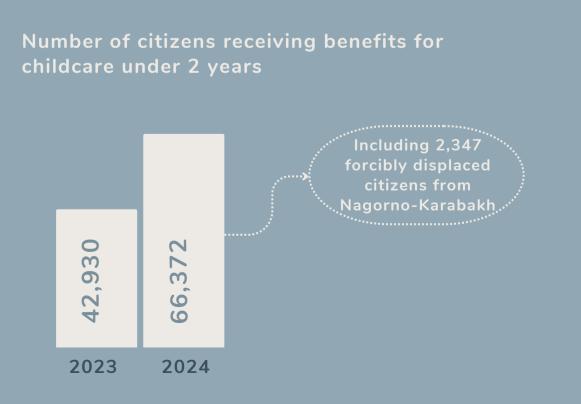

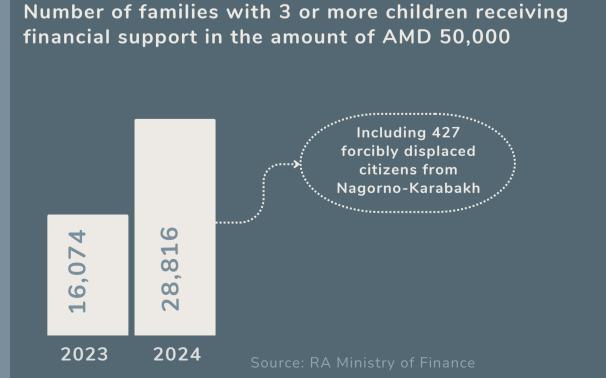
PROGRAMME 1068 - Improving Demographic Situation

- Resources allocated to Benefits for Childcare under 2 years are the largest share or 42.2% of the Programme budget. Resources allocated for these benefits will increase by AMD 8.7 bln and amount to about AMD 29.1 bln.
- Number of beneficiaries will increase by 25,276 individuals compared with the last year and reach 66,372 in 2024.
- 31.6 percent of the programme budget, or about AMD 21.8 bln, will be allocated to the provision of the one-off childbirth benefits.

- Compared to the previous year, the funds allocated for these benefits will increase by 8.8% or AMD 1.8 bln.
- Number of beneficiaries is estimated to reach to 38,790 families in 2024, against 36,261 families last year.
- Number of beneficiaries receiving benefits for the first and second child will increase by 5.4 % and amount to 24,753 families; the number of recipients of benefits for the third and fourth child will increase by 10.3 %, amounting to 13,395 families; and for the fifth and subsequent children will amount to 642 families (increase: 1.3 %).
- In 2024, the number of families with 3 or more children receiving financial support in the amount of AMD 50,000, will be 28,816, including 427 families forcibly displaced from Nagorno-Karabakh
- AMD 17.4 bln drams, or 25.3 % of the project budget, will be allocated to provide this financial support, an increase of 66.7 %, or about AMD 7 bln, compared to the previous year.







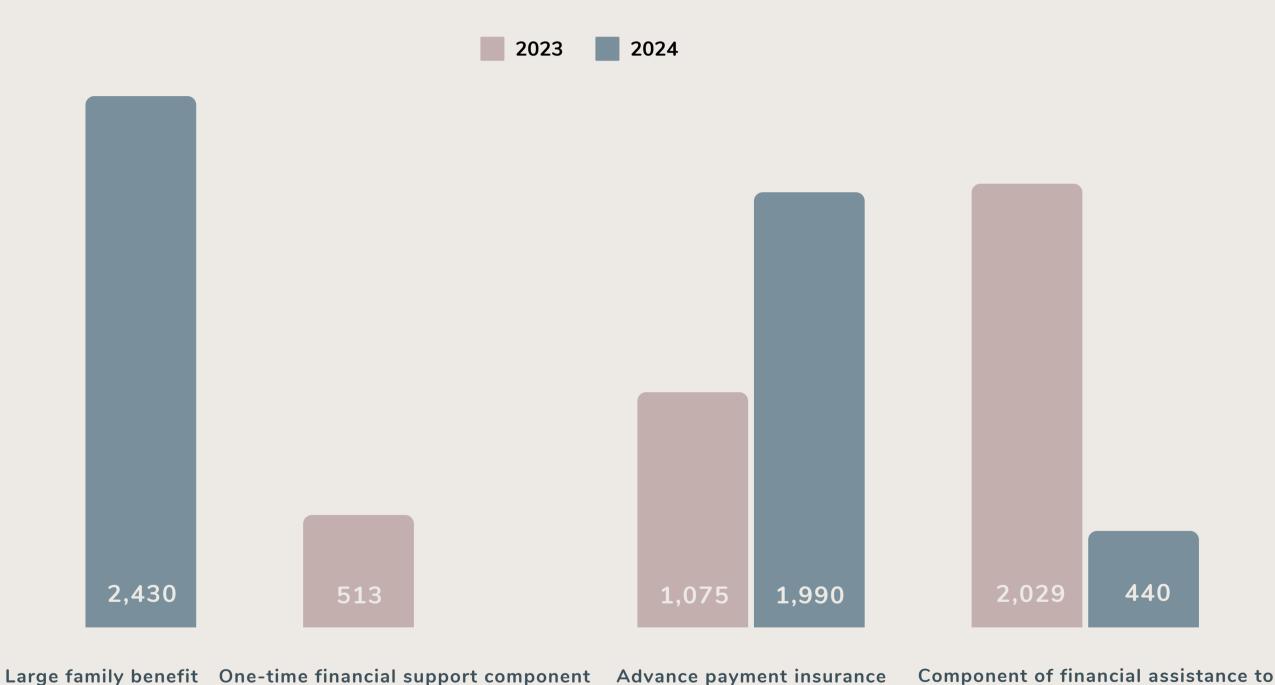

- AMD 606 mln financial recourses is allocated to provide housing to families with children in 2024, which is less by about AMD 2 bln or 77.2 % compared with the last year.
- About 4.860 families will receive housing support through various components of the programme, which are 1,243 more than in 2023.
- Significant increase in the number of families receiving support with the benefit component for large families, and the number of families of the advance payment insurance component for young families.

- More than 72.9 % of the programme budget is allocated to the provision of Maternity Benefit.
- 40,118 beneficiaries will receive maternity benefits in 2024 as compared to 35,814 in 2023. 5.3 % of beneficiaries are forcibly displaced citizens from Nagorno-Karabakh.
- Notably, 43.7 % or 17,530 of the beneficiaries are working people, including 100 forcibly displaced from Nagorno-Karabakh.

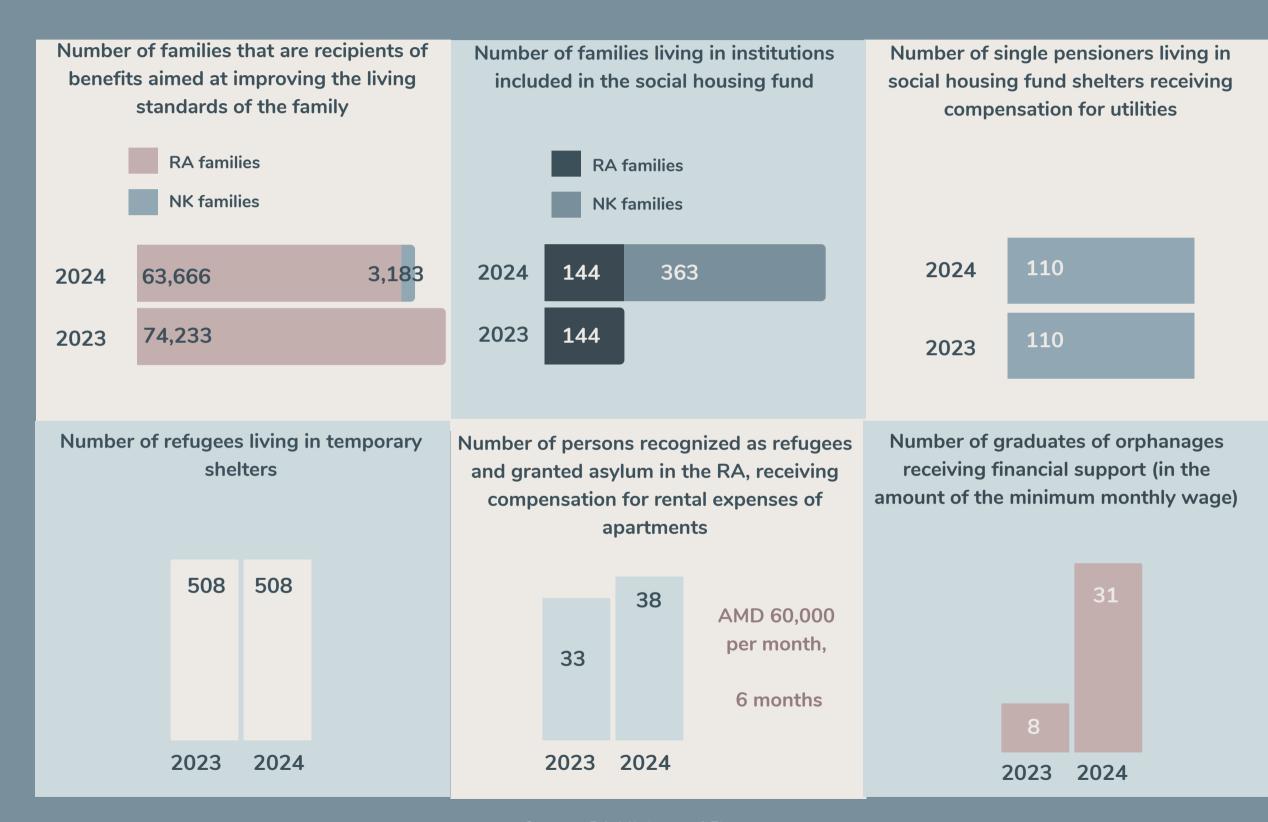

- The scope of the programme was expanded in 2024, a number of measures implemented within the framework of other budget programmes were included in its structure (see the table).
- More than 98.3 % of the programme budget is allocated to providing benefits aimed to increase living standards of the family.

PROGRAMME 1011 - Support to Disadvantaged Social Groups

- Average benefit to increase living standards of the family in 2024 is projected to equal to AMD 37,000. So far, 66,849 families, including 3,183 families forcibly displaced from Nagorno-Karabakh, will receive benefits.
- In 2024, a new system of family benefits aimed at eliminating extreme poverty will be introduced in step-by-step model.
- Models of step-by-step reduction, economic activation of every able-bodied person and inclusion in active employment programmes will be important from the point of view of overcoming poverty.

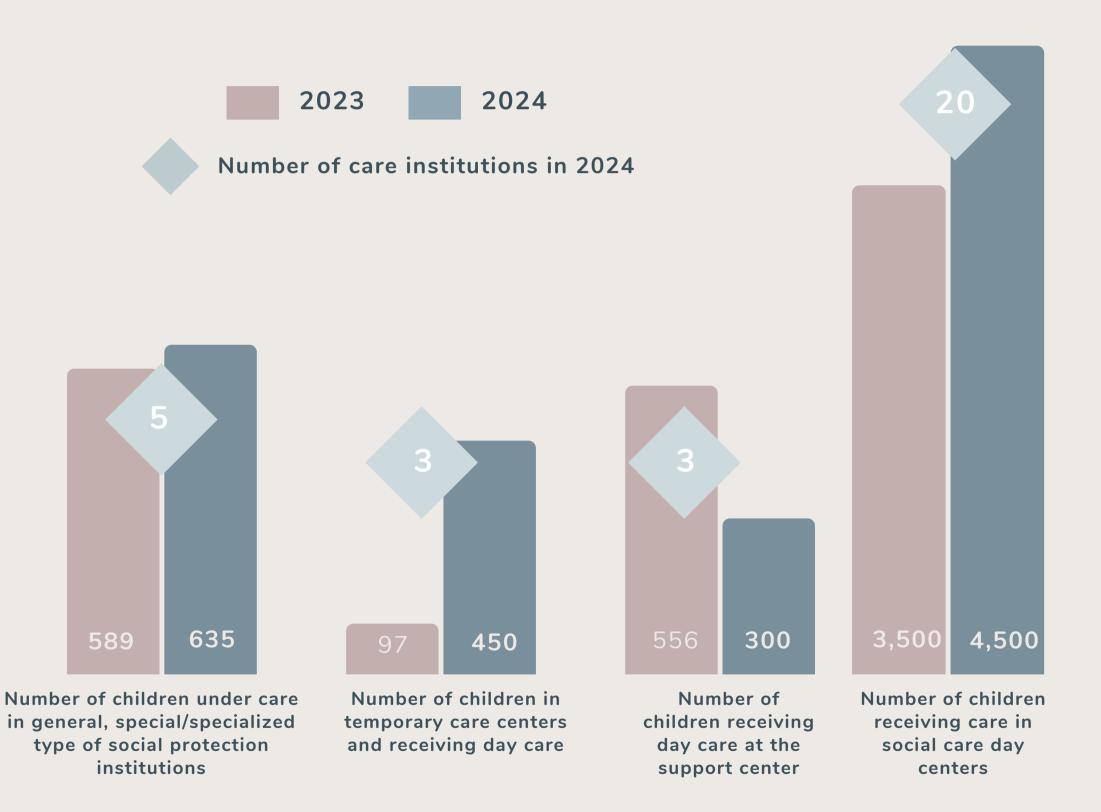

PROGRAMME 1141 - Support to Families, Women and Children

- More than 96.3 % of the programme budget is allocated to provide care and support services for 5,885 children in difficult life situations, including 1,020 displaced children from Nagorno-Karabakh.
- In terms of increase in the volumes of financing, the increase in expenditures for temporary care services for children in difficult life situations is essential; compared to the actual level of the previous year, it has increased by about 3 times.
- Expenditures for round-the-clock childcare services and day-care services to children will increase by 10.8% and 49.0 %, respectively.
- Resources allocated to provide support to care and education of the child in foster families will increase by 50.5 % and amount to AMD 353.8 mln, which will be used to organize care and education of 170 children in 111 foster families, 20 of which are children in difficult life situation as a result of the forced displacement of the population from Nagorno-Karabakh.
- AMD 96.7 mln will be allocated to the support centers for persons subjected to domestic violence: shelter services will be provided to 60 and support services to 1,500 beneficiaries. In addition, AMD 15 mln, which is an increased of 40.8 % compared to last year, is allocated for the temporary support to victims of domestic violence.

- AMD 2 bln or 41.3 % of the budget of Housing Provision Programme will be allocated to providing access to housing for 4,032 families forcibly displaced from different regions of Nagorno Karabakh. In particular, for acquiring real estate or building individual residential house.
- State support for affordable housing in border settlements will be provided to 540 families.
- It is also planned under the programme to pay compensation for renting an apartment for up to six months to convicts released from punishment and who have no place to live. Number of beneficiaries of the measure in 2024 is 375; the amount of the sum allocated for rent is AMD 60,000.
- Housing conditions of 43 homeless families of deceased (killed) soldiers, as well as 100 families of military personnel in need of improved housing conditions, will be improved.

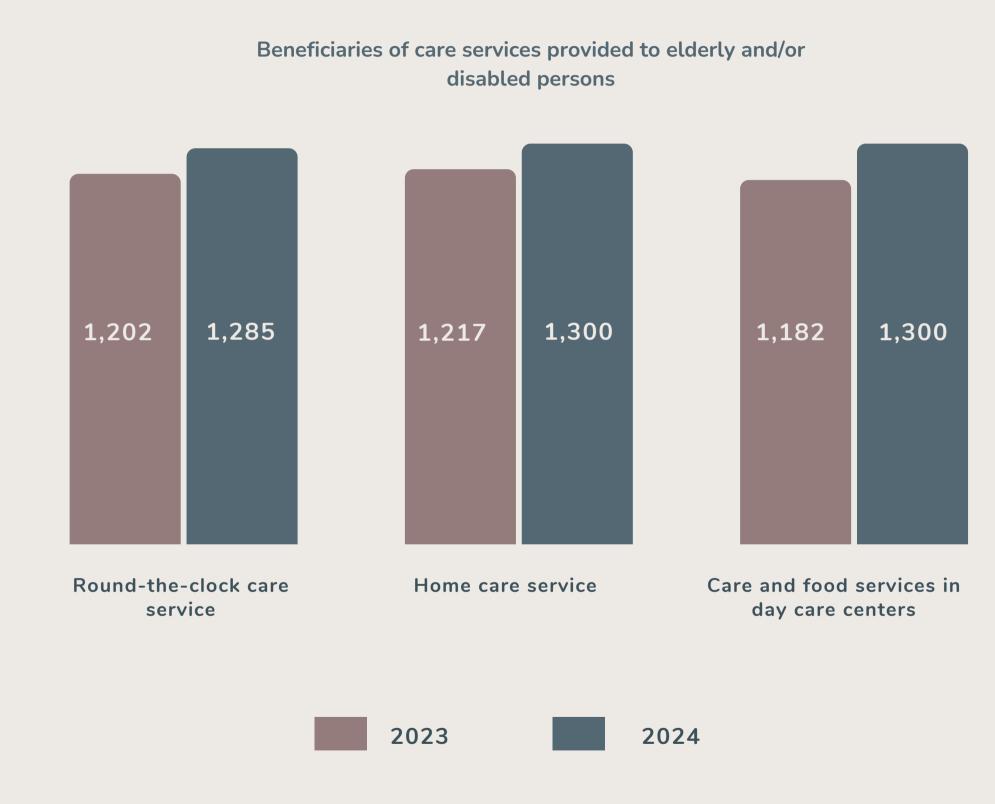

PROGRAMME 1032 - Providing care for the elderly and/or individuals with disability, organizing meals and accommodation for people in difficult life situations

- 1,285 people (including 80 forcibly displaced persons from Nagorno-Karabakh) will receive round-the-clock care in 2024; 1,300 people will receive home care services (including 100 forcibly displaced from Nagorno-Karabakh); 300 people (including 100 forcibly displaced from Nagorno-Karabakh) will receive food in charity canteens.
- Around 100 beneficiaries will be provided with temporary housing for the homeless.
- Works to improve the building conditions of SNCOs providing round-the-clock care will be launched.
- Delegation of services to NGOs through tenders is encouraged. Mission Armenia, Armenian Caritas, Armenian Red Cross Society, Armavir Development Center, and Association for Healthcare and Assistance to Older People NGOs provide services within the framework of the project.

- The scope of inclusion of the programme will be expanded in 2024, and it is planned that the share of programme beneficiaries in the total number of persons with disabilities will increase from 11.1 % to 11.8 %.
- It is planned to allocate around AMD 2.3 bln to the programme in 2024, which is 11.8 % more than the level of the last year. AMD 151.1 mln from this amount will be allocated to 100 beneficiaries of the new "Personal Assistant Service" measure.
- More than 79.3 % of the project budget is allocated to the provision of support through state certificates/ vouchers.
- 445 persons with disabilities will receive social rehabilitation services in 10 day care centers, and 70 persons will receive round-the-clock care services in 5 small community-based group homes.

PROGRAMME 1088- Employment Programme

AMD 638.5 bln

OBJECTIVE

Creating conditions aimed at ensuring permanent and temporary employment of the population.

OUTCOME

Increase in the number of permanent and temporary employed.

- The progeamme budget will be decreased by 28.4 %.
- It is planned to include 1,217 beneficiaries in the employment measures in 2024, of which 942 beneficiaries in the framework of seasonal employment provision measure.
- AMD 289.6 mln is allocated to organize vocational/professional training and ensure employment of unemployed persons who participated in the military operations as a result of war unleashed by Azerbaijan in 2016 and 2020, the service will be provided to 275 beneficiaries.
- In the case of employment of the unemployed within the framework of ensuring employment of unemployed measure, the employer(s) will be provided a one-off compensation for 177 beneficiaries.

- Forcibly displaced persons from Nagorno Karabakh are beneficiaries of the programme. The programme budget in 2023 was over AMD 28.7 bln.
- 114,009 persons were beneficiaries of the programme in 2023; they received one-off monetary assistance to cover the housing and communal costs, as well as basic consumer expenses.
- Social assistance in 2024 will continue only to cover the expenses for living in temporary housing and the utility costs, AMD 15 bln is allocated for this purpose.
- It is planned to provide the social support for a period of 3 months in the amount of AMD 50,000 per month.
